INVITATION TO PUBLIC CONSULTATIVE WORKSHOPS ON THE REVIEW OF KENYA PIPELINE COMPANY (KPC) IMPORT HANDLING, PRIMARY STORAGE AND TRUCK LOADING TARIFFS

The Energy and Petroleum Regulatory Authority (EPRA) is Kenya's energy sector regulatory agency established under the Energy & Petroleum Act, 2019 with responsibility for economic and technical regulation of the electric power, renewable energy, coal and petroleum subsectors.

KPC has submitted an application to review the import handling, primary storage and truck loading tariffs pursuant to provisions of the Act, which mandates EPRA to review and approve existing tariffs every three (3) years.

In accordance with Article 33 of the Constitution of Kenya 2010, EPRA will embark on public and stakeholder consultations with a view to receiving comments on the KPC jetty handling and primary storage tariff application at the regions listed below and the specified dates from 8:00 a.m. to 1:00 p.m.
