MAXIMUM RETAIL PETROLEUM PRICES IN KENYA FOR THE PERIOD 15TH FEBRUARY 2025 TO 14TH MARCH 2025

In accordance with Section 101(y) of the Petroleum Act 2019 and Legal Notice No.192 of 2022, the Energy & Petroleum Regulatory Authority (EPRA) has calculated the maximum retail prices of petroleum products which will be in force from **15th February 2025 to 14th March 2025**.

In the period under review, the maximum allowed petroleum pump prices for **Super Petrol, Diesel and Kerosene remain unchanged**.

The prices are inclusive of the 16% Value Added Tax (VAT) in line with the provisions of the Finance Act 2023, the Tax Laws (Amendment) Act 2024 and the revised rates for excise duty adjusted for inflation as per Legal Notice No. 194 of 2020.

The average landed cost of imported **Super Petrol** increased by **2.80%** from **US\$611.69** per cubic metre in December 2024 to **US\$628.80** per cubic metre in January 2025; **Diesel** increased by **4.20%** from **US\$644.10** per cubic metre to **US\$671.14** per cubic metre while **Kerosene** increased by **4.89%** from **US\$649.64** per cubic metre to **US\$681.44** per cubic metre over the same period.

The changes in the landed costs are summarized in the table 1.

Currently, Kenya imports all its petroleum product requirements in refined form and the products are traded in international markets based on a pricing benchmark. Table 2 indicates the trend of petroleum prices in the international markets.

Further, the trade of petroleum products in the international markets is denominated in United States Dollars (USD), and an exchange rate is applied to convert the USD to KShs during the computation of local pump prices. Table 3 indicates the trend of the USD-KShs. exchange rate in the last 12 months.
