

a) Requirements for Licence for Import, Export and Wholesale of LPG:

- 1. Certificate of Incorporation / Business Registration Certificate;
- 2. *CR12* from the Registrar of companies (should not be older than 1 year at the time of submission of the application. Further, if a Limited company appears as part of the shareholders, provide the company's CR12 plus all the Directors' IDs);
- 3. Legible Copies of Identification Documents (*IDs/Passports for all the directors*);
- 4. Valid Work Permits Class "G" or "D" for all foreign directors working in Kenya (Foreign directors not resident in Kenya should provide a notarized declaration. Further, any employee given Powers of Attorney by a foreign director should provide a copy of their identification document);
- 5. A valid Tax Compliance Certificate for the applicant from the Kenya Revenue Authority;
- 6. A valid Single Business Permit for the premises of operation from the respective County Government;
- 7. Proof of access to a licensed LPG bulk storage facility through submitting a scan of either:
 - a) A valid licence for a bulk LPG storage facility in the name of applicant or a valid long-term lease (*minimum 5 years*) with an operator of a licensed bulk LPG storage facility; or
 - b) A valid hospitality agreement with an operator of a licensed bulk LPG Storage facility.
- 8. Proof of presence in the Kenyan market by submitting a scan of either:
 - a) Proof of annual bulk LPG throughput of at least 2,000 metric tons; or
 - b) Proof of ownership of a cylinder brand.

b) Online application procedure:

To apply, visit the <u>Licensing Portal</u> on the EPRA website and follow the following steps:

- 1. Click "Create Account";
- 2. Click on "License Management" then select "New Licence Application";
- 3. Select the preferred Category in this case *Import*, *Export and Wholesale of LPG*;
- 4. Read and accept the licence conditions provided and click on "Proceed with registration icon";
- 5. Follow the application process step by step by filling in the required information and click "Save";
- 6. Attach the required documents as per the licence category; and
- 7. Submit the application.

c) Requirements for renewal:

- 1. *CR12* from the Registrar of companies (should not be older than 1 year at the time of submission of the application. Further, if a Limited company appears as part of the shareholders, provide the company's CR12 plus all the Directors' IDs);
- 2. Legible Copies of Identification Documents (IDs/Passports for all the directors);
- 3. Valid Work Permits Class "G" or "D" for all foreign directors working in Kenya (Foreign directors not resident in Kenya should provide a notarized declaration. Further, any employee given Powers of Attorney by a foreign director should provide a copy of their identification document);
- 4. A valid Tax Compliance Certificate for the applicant from the Kenya Revenue Authority;

- 6. Proof of access to a licensed LPG bulk storage facility through submitting a scan of either:
 - a) A valid licence for a bulk LPG storage facility in the name of applicant or a valid long-term lease (*minimum 5 years*) with an operator of a licensed bulk LPG storage facility; or
 - b) A valid hospitality agreement with an operator of a licensed bulk LPG Storage facility.
- 7. Proof of presence in the Kenyan market by submitting a scan of either:
 - a) Proof of annual bulk LPG throughput of at least 2,000 metric tons; or
 - b) Proof of ownership of a cylinder brand.

d) Licence processing period, duration and charges:

- 1. Applications for licences are evaluated within 30 calendar days from date of receipt.
- 2. The licence is valid for a period of one year from the date of issuance.
- 3. No fees are charged for Petroleum Business Licences issued by EPRA.
