CALL FOR PUBLIC COMMENTS ON DRAFT ENERGY (INTEGRATED NATIONAL ENERGY PLAN) REGULATIONS, 2023

The Energy and Petroleum Regulatory Authority (the Authority) is Kenya's energy sector regulatory agency established under the Energy Act, 2019 for the technical and economic regulation of the Electricity, Renewable Energy, Coal and Petroleum subsectors in Kenya.

The Authority has developed Draft Energy (Integrated National Energy Plan) Regulations 2023 within the provisions of Sections 5 and 208 of the Energy Act, 2019. The purpose of the Draft regulations is to provide guidelines on the preparation, content, timelines, publication and monitoring of the Integrated National Energy Plan.

The draft regulations were placed on the Kenya Gazette on 16th June 2023 vide Gazette Notice No. 7849 for public comments. The public is requested to review the aforementioned and provide feedback. Written comments on the regulations, and the associated Regulatory Impact Assessment Report, should be in the prescribed format of the public comments form on the Authority's website www.epra.go.ke. The comments should reach the undersigned not later than 21st July 2023. The memoranda should be marked "PUBLIC COMMENTS ON THE DRAFT ENERGY (INTEGRATED NATIONAL ENERGY PLAN) REGULATIONS 2023" and sent by email to info@epra.go.ke.
